**BILLS SIGNED INTO LAW**

---

**1. SB 346/~~HB 383~~ Public Construction (Chapter No. 2023-134) (DiCeglie/Griffitts)**

**Summary:**

- Requires a local government’s or public entity’s contract for construction services to include a prescribed process that the contractor must use to determine the estimated cost to complete the projects that remain after substantial completion of the overall construction project.
- Distinguishes the reasonable time in which the parties to both local government and public entity construct contracts have to develop the punch list—allowing up to 30 days for contracts under \$10 million, and up to 45 days for contracts of \$10 million or more.
- Allows a local government to retain up to 150% of the estimated cost to complete items on the punch list after it receives a contractor’s request that it pay the contract balance, and clarifies that the local government must pay the withheld cost upon completion of those punch list projects—barring a good faith dispute.
- Requires a local government and public entity to present its good faith dispute in writing before it may refuse to pay on the basis thereof.
- Clarifies that a public entity must pay the remaining contract balance (excluding costs associated with the punch list) only after the punch list has been developed, and within 20 days of its receipt of a proper invoice or payment request.
- Defines a public works project as any activity that is paid for with any state appropriated funds, deleting any dollar threshold entirely. Prohibits geographic location restrictions for the sourcing of a contractor, supplier, or carrier; and wage rate and employee benefit prescriptions; and limits on the source of employee recruitment, training, or hiring.

**2. HB 1379/SB 1632 Environmental Protection (Chapter No. 2023-169) (Steele/Brodeur)**

**Summary:**

- Requires any county or municipality with a basin management action plan (BMAP) within its jurisdiction to include within the capital improvement element of its comprehensive plan a list of projects necessary to achieve the pollutant load reductions attributable to the local government as established in the BMAP.
- Requires the applicable 5-year implementation milestone for new or revised BMAPs to include a list of projects that will achieve the pollutant load reductions needed to meet the total maximum daily load (TMDL) or the load allocations established pursuant to 403.067(6), F.S., and each project must include a planning-level cost estimate and an estimated date of completion.

- Prohibits the installation of new onsite sewage treatment and disposal systems (OSTDSs) within a BMAP area adopted under s. 403.067, F.S., a reasonable assurance plan, or a pollution reduction plan where connection to a publicly owned or investor-owned sewerage system is available. In addition, on lots of 1 acre or less within such areas where a publicly owned or investor-owned sewerage system is not available, the bill requires the installation of enhanced nutrient-reducing OSTDSs or other wastewater treatment systems that achieve at least 50 percent nutrient reduction compared to a standard OSTDS.
- Authorizes DEP to provide grants for projects that reduce the amount of nutrients entering waters that: are not attaining nutrient or nutrient-related standards; have an established TMDL; or are located within a BMAP area, a reasonable assurance plan area adopted by final order, an accepted alternative restoration plan area, or a rural area of opportunity.
- Requires DEP, relevant local governments, and relevant local public and private wastewater utilities, as part of a BMAP that includes an Outstanding Florida Spring, to develop an OSTDS remediation plan for a spring if DEP determines OSTDSs within a BMAP contribute at least 20 percent of nonpoint source nitrogen pollution or if DEP determines remediation is necessary to achieve the TMDL.
- Establishes the Indian River Lagoon (IRL) Protection Program within DEP.
- Increases the contract price for a land acquisition agreement under the Florida Forever program that requires approval by the Board of Trustees of the Internal Improvement Trust Fund from \$1 million to \$5 million.

**3. HB-23/SB 162 Water and Wastewater Facility Operators (Bell/Collins)**

**Summary:**

- Requires issuance of reciprocity licenses for water and wastewater treatment plant operators who are licensed by another state, the federal government, a territory or tribal government with “comparable” license examination to Florida.
- Requires issuance of reciprocity licenses for applicants who performed comparable water or wastewater operator duties in U.S. Armed Forces.
- House Committee substitutes added definition of the term drinking water and wastewater personnel, and requires DEP to adopt rules to implement the provision.
- HB definition of “water and wastewater facility personnel” means any employee of a governmental authority, utility, state, municipal, or county sewerage system, or public water system.

4. **HB 111/SB 1170 Public Financing of Potentially At-risk Structures and Infrastructure (Hunschofsky/Calatayud)**

Summary:

- Creates definitions for “areas at risk due to sea level rise” and “potentially at risk structure or infrastructure.”
- Beginning July 1, 2024, a state-financed constructor may not commence construction of a potentially at risk structure or infrastructure without preparing SLIP study and submit to DEP for publication, including design and siting alternatives and list of flood mitigation strategies evaluated as part of the design.
- HB CS expands Resilient Florida Grant Program to cities and counties for feasibility studies of nature-based solutions and WMD support for local government adaptation planning.

## 6. SB 170/HB 1515 Local Ordinances (Trumbull/Brackett)

### Summary:

- Before enactment of a proposed ordinance, local government must prepare a business impact estimate of direct economic impact of ordinance on private business, estimated regulatory costs, and number of businesses affected.
- Enforcement of ordinances suspended if challenged within 90 days of adoption.
- Does not apply to ordinances required for compliance with state or federal law or regulation, budgeting, implementation of a contract.
- Provides that courts may assess attorney's fees and costs against a local government if a local ordinance is challenged on the grounds that the ordinance is arbitrary or unreasonable.
- Provides for continuance of consideration of proposed ordinance at public meetings without further noticing, addressing recent appellate decision.

**11. HB 1331 Municipal Utilities (Busatta Cabrera)**

**Summary:**

- Original HB would have authorized surcharge of up to 10% by municipality on customers located outside municipal boundaries, excluded municipalities that own, operate, manage, or provide water or wastewater utilities from exemption from regulation by Public Service Commission, and provided that municipality that owns water or wastewater utility may transfer portion of earning to general fund at a fixed percentage established by local referendum.
- HB CS is not as extensive as original language however:
  - The CS limits municipal utility revenue transfers to the general fund to a rate equal to the amount derived by applying the rate of return on equity established annually by order of the PSC. These transfers are further limited based on the percentage of utility customers located outside the city's boundaries. For example, if more than 15% of the utility's customers are located outside municipal boundaries, the transfer rate is reduced by 150 basis points, and if more than 45% of the utility's customers are located outside municipal boundaries, the transfer rate is reduced by 450 basis points.
  - The CS removes the existing provision allowing municipal water and wastewater utilities to add a 25% surcharge to customers outside its boundaries, and adds a provision providing that rates established for customers outside municipal boundaries shall not be more than 25 percent greater than the amount charged to consumers within the municipality (current law allows the rates to be up to 50% greater).
  - The CS creates a requirement that a municipal water or wastewater utility that provides service to consumers within the boundaries of a separate municipality, using a water treatment plant or sewer treatment plant located within the boundaries of that separate municipality, may charge no more than the rates, fees, and charges imposed on consumers inside its own municipal boundaries.
  - The act would take effect July 1, 2024.
- See also SB 1712 and HB 361 which provides for charging municipality that operates as water or sewer utility providing service to customers in a recipient municipality using a facility located in the recipient municipality shall charge the same rate to consumers in the recipient municipality as those inside its own boundaries.
